

LEADERSHIP FOR UNIVERSAL HEALTH COVERAGE (L4UHC)

Enabling collaborative advances in UHC

The L4UHC programme enables senior decision-makers to develop the collaborative skills and collective actions needed to bring together different national stakeholders to advance UHC.

This collaborative approach is especially important for overcoming the political barriers to UHC, with its different interest groups. Significantly, the skills developed are used to initiate practical, collective actions in participating countries, supported by in-country coaches, funding and technical expertise. These actions help catalyse additional initiatives, creating the momentum for greater progress.

Three key skills are developed

Supported by professional facilitators, participants develop the necessary skills through interactive, 4-day sessions in host countries, and hands-on experiences in their own countries.

National, multi-stakeholder teams are formed

L4UHC brings together senior decision-makers from different fields, enabling them to establish multi-stakeholder teams and forge a common vision for advancing UHC.



Practical collective actions deliver results in each country

Each national team develops and implements a series of practical collective actions to catalyse change in their country.



Nepal has reformed how it procures drugs, helping to improve drug availability and distribution.



A payment certification agency was created in **Cambodia**, and quality assessment rolled out nationally.



A decree for establishing a National Insurance Fund has been agreed by the Council of Ministers in **Madagascar**.



Benin is piloting a new insurance scheme in its North Zone, and defined a basic health package.



The one-year programme has 6 stages

1. Connecting with UHC

Understanding UHC's complexity, and developing the leadership skills to observe, sense, and listen. (Host country).

2. Practising skills

Engaging with key stakeholders, viewing challenges from their perspective. (Home country).

3. Defining collective actions

Jointly defining collective actions and practising coalition-building strategies. (Host country).

4. Advancing collective actions

Implementing the selected actions in your home country, supported by local coaches. (Home country).

5. Learning for future UHC reforms

Reflecting on progress, and defining the next stages of reform. (Host country).

6. Post-programme support

Continuing the reforms with development partners. (Home country).


